## Enrollment Information for 2018-19

### **New School High is a public school academy. This means...**

- There is no cost to attend.
- There is no admission test required to attend.
- Enrollment is open to all students eligible to attend a Michigan high school. A student is not required to reside in the community in which the school is located. For example, a student may reside in Ann Arbor and attend New School High, which is located in Plymouth.
- Admission is not based on any measure of achievement, aptitude, or on disability, gender, race, religion, color, national or ethnic origin, or any other basis not permitted by Michigan's public schools.

Families will be notified of enrollment status within 48 hours. Upon acceptance, families must complete and submit:

- A copy of the student's birth certificate
- A copy of the student's immunization records
- A copy of the student's most recent report card
- A copy of the student's most recent IEP, if applicable

Enrollment Forms received after maximum enrollment is reached will be added in the order received to the enrollment list if spaces are available, or to the wait list if spaces are not available. Applications are valid for one academic year only. Once enrolled, students do not need to apply for future years. Please notify New School High if an address, phone number, or email changes. If a family cannot be reached, the student may lose his/her space. If the student will not be attending, please notify the school.
